RACE A Stewards Inquiry was posted into the stretch and, in addition, there were 2 rider objections lodged. An objection was lodged by the rider of fifth place #4 "P H Factor" (Gerardo Corrales) alleging interference by the rider of third place #9 "Kentucky Cool" (John McKee) in the stretch. Also, John McKee aboard third place #9 lodged an objection alleging interference by the rider of second place #3 "Military Force" (Santo Sanjur) in the stretch. After reviewing the race replay and interviewing the involved riders, the stewards determined that #4 caused his own trouble by coming out slightly and bumping #9. #3 always maintained a straight course on the outside and did not interfere with #9, as alleged. Both objections were disallowed and there was no action taken regarding the Stewards Inquiry. There was no change in the order of finish and the race was posted official.
