Roman) alleging interference by the rider of the unofficial winner #1 "Hollybygolly" Luan Machado) in the first turn. After reviewing the race replay and interviewing the riders, the stewards determined that both #1 and #2 steadied when they lacked room going into the turn. There was no change in the order of finish and the race was posted official.

4<sup>th</sup> RACE #5 "Ms Temptation" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian.

5<sup>th</sup> RACE An objection was lodged by the rider of seventh place #8 "Halter Boy" (Brooke Bays) alleging interference by the rider of third place #7 "Enjoy the Cracken" (Samuel E. Bermudez) at the start. After reviewing the race replay and interviewing the riders, the stewards determined that #8 broke a step slow and steadied behind #7. There was no change in the order of finish and the race was posted official.
