6th RACE A Stewards Inquiry was posted when #5 "Bird Set Free" (Isaias Ayala) flipped and unseated her rider at the break. After reviewing the race replay and interviewing the starter and rider, the stewards determined that the horse was not restrained and the front doors opened timely with the others, but that the mare caused her own trouble when she reared at the start. Because she was not precluded from obtaining a fair start #5 was considered a starter. There was no action taken and the race was posted official.
