TEST: 1st 5 & 10, 2nd 1-clm voided & 9-clm voided, 3rd 2 & 8, 4th 1 & 9, 5th 3 & 6 (C 5), 6th 2 & 6, 7th 4 & 12, 8th 2 & 3.

1st RACE #2 "Go On Girl" (Emmanuel Esquivel) was a late scratch by the stewards when she broke through the starting gate, unseating her rider, evaded the outriders and flipped over the outside rail. Both horse and rider escaped injury.

2nd RACE The claims of both #1 "Kantpaythetoll" and #9 "Joker On Jack" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE #12 "Mo Betty" (Gerardo Corrales) reared and ducked out at the start, unseating his rider. The horse ran with the field and was caught without incident. The rider escaped injury.

5th RACE An objection was lodged by the rider of third place #10 "Brazen Boy" (Chris Landeros) alleging interference by the rider of the unofficial winner #3 "Storm Daddy" (Malcolm Franklin) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight interference by the rider of #3 occurred at the finish line and did not affect the order of finish. There was no change made and the race was posted official.

6th RACE An objection was lodged by the rider of second place #8 "Bel Aria" (Gerardo Corrales) alleging interference by the rider of the unofficial winner #6 "Fast Giselle" (Alex Achard) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official.

7th RACE #6 "Rudimentary Drink" (Alex Achard) was a late scratch from the post parade on the advice of the KHRC veterinarian

#8 "Quicky Desire" (Joseph D. Ramos) broke through the gate prior to the start, but the rider stayed aboard. The horse was reloaded and the start was without incident.

#10 "Joy Enamorada" (Jane Elliot) was pulled up abruptly approaching the 5/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized.

8th RACE An objection was lodged by the rider of fourth place #3 "Luna Moth" (Luna Machado) alleging interference by the rider of the unofficial winner #2 "Condone" (Declan Cannon) leaving the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official.
