2nd RACE The scratch of #3 "Revenio" after the opening of wagering reduced the field to six, necessitating the cancellation of the Super High Five. The mutuels department made the proper refunds.

Voided claim - no funds

3rd RACE CLEAR

4th RACE Race 4 was taken off the turf. The change of surface was announced after the start of the Pick 5 that began in Race 1, making race 4 an "All Win" for those Pick Five wagers.

The scratch of #7 "Private Island" after the opening of wagering reduced the field to six, necessitating the cancellation of the Super High Five. The mutuels department made the proper refunds.

#6 "British Royalty" (Luis Saez) was distanced, pulled up and left the track on his own power.

5th RACE Voided claim - owner not licensed

6th RACE Super High Five wagering was not offered when the field was reduced to six prior to the opening of wagering.


7th RACE CLEAR
