TEST: 1<sup>st</sup> 4 & 6, 2<sup>nd</sup> 2 & 4 (C 1 & 5), 3<sup>rd</sup> 7 & 8, 4<sup>th</sup> 3 & 6, 5<sup>th</sup> 2 & 4, 6<sup>th</sup> 8 & 10 (C 6 & 9), 7<sup>th</sup> 3 & 6, 8<sup>th</sup> 1 & 4, 9<sup>th</sup> 1 & 2.

1<sup>st</sup> RACE Super High Five and Superfecta wagering were not offered when the field was reduced to five betting interests prior to the opening of wagering.

2<sup>nd</sup> RACE Voided claim - insufficient funds

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE An objection was lodged by the rider of sixth place #9 "Rosalita" (James Graham) alleging interference by the rider of second place #7 "Tracy Flick" (Joel Rosario) near the 3/16 pole. After reviewing the race replay and interviewing the riders the stewards determined that #7 angled out sharply and caused both #9 and seventh place #8 to steady and lose momentum. For the interference, #7 was disqualified from second and placed seventh, behind #8. Official order of finish: 3-1-6-4-9


5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE #4 "John Edward" (Albin Jimenez) was pulled up at the 1/2 mile pole and required the assistance of the KHRC veterinarians and the horse ambulance. After being evaluated it was determined that the horse did not appear to have suffered a serious injury and was placed on the See Vet list.

7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.
