- 3rd RACE A Stewards Inquiry was posted when #6
 "Ransomware" (Santo Sanjur) fell and unseated his rider shortly after the start. The horse got up and began to run the wrong way in the stretch before being expertly caught by the outrider and removed from the track. When it became apparent that the fallen rider, who was being attended to by medics, could not be moved, the stewards made the decision to radio the outriders and order that the race be stopped. The horses were pulled up in the turn without incident and the stewards declared the race NO CONTEST. The mutuels department made the proper refunds. Claims that had been submitted for several horses were voided. Sanjur was transported to the hospital. The horse escaped serious injury.
- 4th RACE Program correction #9 "Brooklyn Can Dance" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

The claim of #3 "Mustang Lady" was voided pursuant to HISA Rule #2262 when the horse BLED and was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
