10th RACE An objection was lodged by the rider of second place #1 "Excellent Truth (IRE)" (Flavien Prat) alleging interference by the rider of the unofficial winner, #2 "Choisya (GB)" (Luis Saez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled out slightly while clear and the rider of #1 changed course when he lacked room. There was no change in the order of finish and the race was posted official.

11th RACE #4 "Spun Up" (Mitchell Murrill) popped the front doors of the starting gate open, but was held in place by the assistant starter and the rider stayed aboard. The doors were closed and the start was without incident.
