3rd RACE The claim of #2 "Goodbetterbest" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

5th RACE #2 "Run for Reagan" (Joseph Ramos) broke through the gate prior to the start, but the rider stayed on. The horse was examined by the KHRC veterinarian and approved, reloaded, and the start was without incident.

#8 "Goin to the Show" (Julien Leparoux) finished sixth, was pulled up abruptly after the finish, and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the horse had suffered a catastrophic injury to his right foreleg and he was humanely euthanized.


