1st RACE Voided claim - used stable name only

2nd RACE An objection was lodged by the rider of third place #6 "Matt's Honey" (Mitchell Murrill) alleging interference by the unofficial winner #2 "Positive Vibes" (James Graham) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled in and caused #6 to steady and lose momentum. For the interference #2 was disqualified and placed third, behind #6. Official order of finish: 7-6-2-5-4
