10<sup>th</sup> RACE #3 "Shantisara (IRE) (Flavien Prat) finished second and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the filly had returned lame and she was excused from the test barn and placed on the See State Vet list.
