An objection was lodged by the rider of fourth place #2 "Ask Amanda: (Gerardo Corrales) alleging interference by the rider of third place #3 "Devil of Paradis" (Constantino Roman) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification. There was no change in the order of finish and the race was posted official.

2nd RACE #7 "Sing for Mo Money" (Alex Achard) was pulled up nearing the 1/8 pole and required the assistance of the KHRG veterinarians and the horse ambulance. When it was determined that the colt had suffered a serious injury to his left foreleg, he was transported to a local clinic for diagnostics and further evaluation. After an examination and consultation with the surgeon, the colt was humanely euthanized due to poor prognosis.

#10 "Trim Castle" "Edgar Morales" was pulled up abruptly when he bumped into #7 near the 1/8 pole and nearly unseated Morales, but escaped injury.
