1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE A Stewards Inquiry was posted involving the stretch run and, in addition, an objection was lodged by the rider of second place #1 "Beniah" (Luis Saez) alleging interference by the rider of the unofficial winner #5 "Justinthenickoftime" (Tyler Gaffalione) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 drifted out, making contact with #1, causing him to steady and lose momentum. For the interference #5 was disqualified and placed second behind #1. Official order of finish 1-5-2-3

2<sup>nd</sup> race cont The claim of #1 "Beniah" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE #1 "Skyvalue" (Gabriel Saez) was eased and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was placed on the See State Vet list.


6<sup>th</sup> RACE A Stewards Inquiry was posted involving the stretch run and, in addition, an objection was lodged by the rider of third place #2 "Mobeatyabad" (Luis Saez) alleging interference by the rider of second place #1 "Alfie Solomons" (John Valezquez) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #1 drifted out, making contact with #2, causing him to steady and lose momentum. For the interference #1 was disqualified and placed third behind #2. Official order of finish: 6-2-1-4

The claim of #1 "Alfie Solomons" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

7<sup>th</sup> RACE Super High Five wagering was not offered when the field was reduced to six prior to the opening of wagering,

8<sup>th</sup> RACE Voided claim - owner name misspelled

9<sup>th</sup> RACE An objection was lodged by the rider of second place #4 "Commanders Place" (Florent Geroux) alleging interference by the rider of the winner #2 "Nevisian Sunrise" (Joel Rosario) in the stretch. After reviewing the race replay and interviewing Geroux, the stewards determined that it was #4 that came in and bumped the #2, the winner. There was no change in the order of finish and the race was posted official.
