2<sup>nd</sup> RACE The claim of #3 "Stonemont Reunion" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5<sup>th</sup> RACE Voided claim - insufficient funds

#1 "Good Willie" (Joe; Rosario) was a late scratch from the post parade on the advice of the KHRG veterinarian.

The claim of #8 "Syntagma" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

A Stewards Inquiry was posted when #4 "Keep It Easy" (Corey J. Lanerie) unseated his rider at the start. After reviewing the race replay, the stewards determined that the colt had stumbled badly and unseated Lanerie. There was no action taken and the race was posted official. The horse ran with the field and was caught without incident. The rider escaped injury.

8<sup>th</sup> RACE A Stewards Inquiry was posted involving the start of #4 "Run Carson" (John Velazquez) who broke awkwardly and well behind the field. After reviewing the race replay and interviewing the starter and rider, the stewards determined that #4 popped the front doors open just prior to the start and was still being held onto by the assistant starter when the field was dispatched. The stewards determined that the horse was precluded from obtaining a fair start. #4 "Run Carson" was declared a NON-STARTER by the stewards and the race was posted official. The mutuels department made the proper refunds.


