RACE #13 "Razzaluna" (Gabriel Saez) unseated her rider in the post parade, but the horse did not get loose. The rider remounted and raced without incident.

#8 "Saint Sista" (Jane Elliott) unseated her rider in the post parade and was a late scratch by the stewards when she evaded the outriders and ran completely around the racetrack.

RACE The claim of #7 "Longshadow" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

A Stewards Inquiry was posted involving the unofficial winner #1 "Foreign Relations" (Flavien Prat) and #11 "Master of the Ring" (Tyler Gaffalione) who fell and unseated his rider near the 1/8 pole. After reviewing the race replay and interviewing Flavien Prat, the stewards determined that #1 bore in and caused #11, who was between horses, to clip his heels and fall. For the interference, #1 was disqualified and placed last, #11 Master of the Ring" suffered a catastrophic injury to his right knee in the fall and he was humanely euthanized. Tyler Gaffalione escaped injury.
