
5th RACE Voided claim - insufficient funds


An objection was lodged by the rider of sixth place #10 "Oneofthegoodguys" (Angel Serpa) alleging interference by the rider of second place #4 "Teen Idol" (Luan Machado) near the 1/2 mile pole. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

6th RACE #3 "Honky Tonk Highway" (Brian Hernandez, Jr.) was a late scratch from the post parade on the advice of the KHRGC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.
