1st RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering

Voided claim - track misspelled on envelope
Voided claim - insufficient funds

2nd RACE The claim of #2 "Romany Road" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE #8 "Cloud Number Nine" (Micah Meeks) finished fourth and BLED

4th RACE #6 "Oubliette" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian.

5th RACE CLEAR


6th RACE #4 "East Village" (Brian J. Hernandez, Jr.) was pulled up near the 1/4 pole and left the track on his own power. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

7th RACE A Stewards Inquiry was posted involving the stretch run and, in addition, objections were lodged by the trainer (Christopher Davis) and rider of second place #3 "Frosty Indulgence" (Luan Machado) and the rider of third place #6 "Elnajd" (Irad Ortiz, Jr.) alleging interference by the rider of the unofficial winner, #4 "Tre Italiani" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders of #3, #4, #6 and fourth place #9 "Tamino" (Jose L. Ortiz), the stewards determined that #4 angled out and caused #6 and #9 to steady and lose momentum. For the interference, #4 was disqualified from first and placed fourth, behind #9. Official order of finish: 3-6-9-4

#10 "Northern Chill" (Luis Saez) was pulled up near the 1/4 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had suffered a slight injury and he was placed on the See Vet list.

8th RACE #5 "Archimedes" (Flavien Prat) was eased and left the track on his own power. It was later reported by the KHRG veterinarians that the horse had returned lame and he was placed on the See State Vet list.
