An objection was lodged by the rider of second place #4 "Midnight J J" (Luan Machado) alleging interference by the rider of the unofficial winner #2 "Picasso" (Irad Ortíz, Jr.) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.



5<sup>th</sup> RACE CLEAR



7<sup>th</sup> RACE #8 "Invader" (John Velazquez) finished last and required the assistance of the KHRC veterinarians and the horse amulance. It was reported that the horse had returned lame and was placed on the See State Vet list.

8<sup>th</sup> RACE Voided 4 claims - submitted by the same owner for 4 different horses
