RACE There was a 10 minute delay when #1 "Jubilant Joanie" (Reylu Gutierrez) was scratched after she flipped in the starting gate, became stuck underneath it, and required the assistance of the KHRC veterinarians and the horse ambulance. The horse suffered several serious lacerations and was transported to a Lexington clinic. A claim that had been submitted for the horse was voided.

RACE A Stewards Inquiry was posted involving the stretch run and, in addition, an objection was lodged by the rider of sixth place #2 "Encourage" (David Cohen) alleging interference by the rider of fourth place #1 "Buy Me Candy" (Vincent Cheminaud) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #1 angled in near the 1/16 pole and caused #2 to steady and lose momentum. For the interference, #1 was disqualified from fourth and placed sixth, behind #2. Official order of finish: 6-7-3-4
