1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

The claim of #6 "Helen's Little Sis" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE #4 "Missile Cruiser" (Vincent Cheminaud) finished eighth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.


