1st RACE Voided claim - track misspelled on envelope

2nd RACE Both #2 "Glitz and Ritz" (Jose L. Ortiz) and #7 "Might Could" (Gabriel Saez) were late scratches from the post parade on the advice of the KHRG veterinarian. The scratches reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

3rd RACE Voided claim - Owners not licensed
Voided claim - incorrect date (year)
Voided 2 claims - insufficient funds

4th RACE Voided claim - insufficient funds
Voided claim - used stable name only

The claim of #3 "Nine Ball" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE CLEAR

6th RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.


#4 "Queen Jubilee" (Jose L. Ortiz) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch further reduced the field to three, necessitating the cancellation of the exacta. The mutuels department also opted to cancel PLACE wagering. The mutuels department made all of the proper refunds.

7th RACE Program correction - #8 "Chiseler" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

8th RACE #2 "Virgin Colada" (Flavien Prat) was pulled up when she bolted entering the backstretch, and left the course on her own power.

9th RACE CLEAR

10th RACE #1 "Strong Destiny" (Fernando De La Cruz) was fractious at the break and unseated her rider. The filly ran with the field and was caught without incident. The rider escaped injury.
