RACE Race 2 was taken off the turf and was contested on the main track at 4-1/2 furlongs, as specified in the heading of the race.

RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

The claim of #6 "Toxic Love" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
