TEST: 1<sup>st</sup> 4 & 8, 2<sup>nd</sup> 8 & 12, 3<sup>rd</sup> 4 & 6, 4<sup>th</sup> 7 & 9, 5<sup>th</sup> 1 & 8, 6<sup>th</sup> 3 & 4, 7<sup>th</sup> 5-clm voided & 6 (C 2), 8<sup>th</sup> 2 & 3.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #10 "Home Run Hank" (Jareth Loveberry) was scratched by the stewards when he unseated his rider in the post parade and ran loose, evading the outriders.

3<sup>rd</sup> RACE #3 "Wolfe County" (Brian J. Hernandez, Jr.) was pulled up abruptly near the 3/4 pole and required the assistance of the KHRC veterinarians and the horse ambulance. After diagnostics were performed by the private veterinarian, the horse was humanely euthanized due to the serious injury to his left foreleg.



8<sup>th</sup> RACE #7 "Broadway Boogie" (Jorge Ruiz) finished fifth and required the assistance of the KHRC veterinarian and the horse ambulance. It was later reported that the horse had not suffered a serious injury.
