## INCIDENTS/INQUIRIES/OBJECTIONS

- Race 2 → #8 Mr Andreychuk was placed on the Judges List Poor Performance
- Race 8 → #1 Frozen Shark was forced inside the pylons prior to the top of the stretch by #9 Just A Start causing #1 Frozen Shark to Finish while off the course. #1 Frozen Shark was place 8<sup>th</sup> Placed 10<sup>th</sup> due to being off course at finish. Then, the Board of Judges agreed #9 Just A Start did interfere with #1 Frozen Shark and was 4<sup>th</sup> placed 10<sup>th</sup> due to interference and all others were placed accordingly. The race was given a new top four of #4 #7 #2 #6 and the race was allowed to go official.
- Race 11 → #4 Dragons Better did cause interference to #1 #3 #6 #8 #9 -#10 prior to the ¼ mile marker by taking up abruptly in front of a field of horse. #4 Dragons Better was 7<sup>th</sup> placed 10<sup>th</sup> behind offended horses and the race was allowed to go Official.
