7th RACE There was a 46 minute weather delay when a severe thunderstorm came through the area. During the delay the horses remained in the paddock. After the storm subsided, the decision was made to move the scheduled turf race to the sloppy main track. Due to the change of surface there were five additional late scratches that reduced the field to five, necessitating the cancellation of the Superfecta. The mutuel department made the proper refunds. Also, all multi race wagers involving Race 7 became an "ALL WIN".
