5<sup>th</sup> RACE #3 "Joe's Candy" (Irad Ortiz, Jr.) popped the front doors of the gate open, but was held in place by the assistant starter and the rider stayed aboard. The doors were closed and the start was without incident.

6<sup>th</sup> RACE CLEAR  
 7<sup>th</sup> RACE Voided claim - no funds

#4 "Vino Subito" (Christopher A. Emigh) was pulled up near the 1/4 pole and required the assistance of the KHRG veterinarians and the horse ambulance. A claim that had been submitted for the horse was voided. It was later reported that the horse had been transported to a local clinic for additional diagnostics and consultation.

After the results of the 22 way shake for #3 "McIlroy" had been reported to the stewards it was determined that the winner of the shake (Edwin Joel Martinez) did not have the appropriate funds in his account to cover the claim. The stewards ordered the claim voided and instructed the claims clerk to contact the 21 parties whose claims were valid for a re-shake. Ultimately, Rachel Gerson was awarded the horse in the new shake. The horse remained in the test barn and in the possession of the previous trainer until the new connections were announced.

8<sup>th</sup> RACE A Stewards Inquiry was posted involving several horses in the stretch. An objection was lodged by the rider of fourth place #4 "Furio" (Jose L. Ortiz) alleging interference by both the rider of third place #1 "This Is Uskar" (Edgar Morales) and second place #5 "Owen Almighty" (Joel Rosario). An additional objection was lodged by the rider of second place #5 alleging interference by the rider of the unofficial winner, #7 "U Devil You" (John Velazquez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #1 drifted out and caused #4 to steady and lose momentum. For the interference #1 was disqualified from third and placed fourth, behind #4. The other objections were disallowed.

9<sup>th</sup> RACE Jackpot 8 wagering was not offered when the field was reduced to seven prior to the opening of wagering. Odd vs. Even wagering was not offered when only two horses with odd numbers remained in after scratches, in conflict with the rules governing the wager.
