7<sup>th</sup> RACE Voided claim - no funds


8<sup>th</sup> RACE CLEAR

There was a 25 minute delay due to a severe thunderstorm that passed through the area. During the delay the horses remained in the paddock without incident.

10<sup>th</sup> RACE Voided 2 claims - both claims submitted by the same stable for a single horse
