1<sup>st</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2<sup>nd</sup> RACE #8 "Accost" (Flavien Prat) finished ninth (last) and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

3<sup>rd</sup> RACE CLEAR

5<sup>th</sup> RACE #7 "C K Wonder" (Tyler Gaffalione) was pulled up near the 1/2 mile pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

After the race was posted official and the prices were posted, the stewards received a call from a patron regarding the odds of the winner, #12 "U Devil You". The information received alleged that the posted odds of #12 when he entered the winner's circle were 13-1, but the horse had only paid \$18.74 to win. The stewards transferred the call to the mutuels department. The stewards later contacted the mutuels manager for an explanation and to instruct the department to file a report with the KHRG Director of Pari-Mutuel Wagering to review the incident.


