A Stewards Inquiry was posted involving the stretch run and, in addition, an objection was lodged by the rider of second place #5 "Serene Seraph (IRE)" (Jose Ortiz) alleging interference by the rider of the unofficial winner, #10 "Chilled" (Axel Concepcion) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #10 ducked out into the path of #5 near the 1/16 pole, causing #5 to steady sharply and lose momentum. For the interference, #10 was disqualified from first and placed second, behind #5. Official order of finish: 5-10-2-13


