## INCIDENTS / INQUIRIES / OBJECTIONS / JUDGES LIST

- Race 1 - #7 Bingbingbing was placed on the Judges List – Break Off Qualifier
- Race 3 - #8 Sissy's Chrome was placed on the Judges List – Break Off Qualifier
- Race 5 – Due to #6 Mr Mattjesty slowing the pace considerably before the ½ mile marker the #9 - #3 - #2 - #1 - #4 were all interfered with. #1 went into the safety lane to avoid an incident which caused confusion for the rest of the race. After a lengthy inquiry and discussions, the Board of Judges determined due to the actual order of finish no placing was needed.
- Race 6 - #4 Caviart Shetland did shy away from the horse in front of him past the ¾ mile marker coming down into the #9 So I Likeit Dirty causing interference and after discussion with the drivers the Board of Judges agreed #4 was to be 5<sup>th</sup> placed 8<sup>th</sup> and all others adjusted accordingly.
