7th RACE A Stewards' Inquiry was posted when #6 "Miss Kitty Boom" (John Velazquez) unseated her rider at the start. After reviewing the race replay, the stewards determined that the horse had stumbled at the break, unseating Velazquez. There was no action taken and the race was posted official. The horse ran with the field and was caught without incident. The rider escaped injury.


8th RACE A Stewards' Inquiry was posted when #4 "High Go" (Tyler Gaffalione) fell while in tight quarters near the 5/8 pole and unseated his rider. #6 "Tobin Lee" (Gabriel Saez) was directly behind the incident and Saez quickly reacted and attempted to pull his horse up to avoid the fallen horse and rider. After reviewing the race replay and interviewing the riders of the unofficial winner, #1 "General Graham" (Jose Ortiz), third place #9 "Kid Twist" (Adam Beschizza) and, when he was eventually available, Gaffalione, the stewards determined that neither rival #1 or #9 had caused the incident. There was no change in the order of finish and the race was posted official. The KHRG veterinarians attended to the downed horse, who was eventually humanely euthanized on the racetrack due to his catastrophic injuries.
