
7<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.


8<sup>th</sup> RACE CLEAR

9<sup>th</sup> RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, an objection was lodged by the rider of fourth place #1 "Mansa Musa (IRE)" (Junior Alvarado) alleging interference by the rider of second place #6 "No Nay Mets (IRE)" (Irad Ortiz, Jr.) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #6 angled out into the path of #1 and caused him to steady and lose momentum. For the interference, #6 was disqualified from second and place fourth, behind #1. Official order of finish: 7-11-1-6-13
