4th RACE #1 "Ghostly Gal" (Vincent Cheminaud) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

5th RACE A Stewards Inquiry was posted involving the start of #3 Mink Stole (Luis Saez) who unseated her rider at the break. After reviewing the race replay, the stewards determined that the horse had stumbled and unseated the rider, and no other rival was involved. No action was taken and the race was posted official. The horse ran with the field and was caught without incident. The rider was not injured.
