1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

The claim of #5 "Battle Creek" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE #5 "Shesthebiggame" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRC veterinarian.

3rd RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

4th RACE An objection was lodged by the rider of second place #8 "Uninvited Guest" (Joseph Rocco, Jr.) alleging interference by the rider of the unofficial winner #1 "Hawk of War" in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.
