#5 "Plot the Dots" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds. A claim that had been submitted for the horse was voided.

7<sup>th</sup> RACE #10 "Bosque Redondo" (Jareth Loveberry) finished tenth and required the assistance of the KHRC veterinarians and the horse ambulance. After being evaluated the horse was transported to a Lexington clinic for further diagnostics. It was later reported that the horse was humanely euthanized due to his injuries and poor prognosis for recovery.

8<sup>th</sup> RACE The claim of #3 "Crump" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
