After reviewing the race replay and interviewing the riders, there was no interference and the race was posted official.

6<sup>th</sup> RACE Due to an error by the KHRC veterinarian #9 "Cruz Bay" was mistakenly not treated with Lasix prior to the administration deadline. The filly was permitted to race without the medication and the change was posted and announced prior to the opening of wagering.
