5<sup>th</sup> RACE #7 "Final Shipman" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

The claim of #6 "Freaks Go" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
