1st RACE This race was taken off the turf and contested at five furlongs on the main track. The change was posted and announced prior to the opening of wagering.

There was a 35 minute weather delay as a strong storm with lightning passed through the area. The horses were brought back to the paddock from the post parade and remained there during the delay.

2nd RACE CLEAR

3rd RACE Super Hi-5 wagering was mistkenly listed as a betting option on the program but was not offered as the race was carded with six betting interests.

4th RACE The race was taken off the turf and contested at 1-1/16 miles on the main track. The change was posted and announced prior to the opening of wagering.

#6 "Winter Holiday" (Edgar Morales) was a late scratch from the post parade on the advice of the KHRG veterinarian.

5th RACE CLEAR

6th RACE The race was taken off the turf and contested at one mile on the main track. The change was posted and announced prior to the opening of wagering. The scratches reduced the field to six, necessitating the cancelation of the Super Hi-5. The mutuels department made the proper refunds.

7th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

10th RACE Jackpot 8 wagering was not offered when the field was reduced to seven.

Odd vs. Even wagering was not offered when only two horses with odd numbers remained in after scratches, in conflict with the rules governing the wager. prior to the opening of wagering.
