After reviewing the race replay and interviewing all involved riders, the stewards determined that #2 lacked room and was checked sharply to change course by her rider. There was no change in the order of finish and the race was posted official.

5<sup>th</sup> RACE The claim of #4 "Run for Reagan" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.Super Hi-5

6<sup>th</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.
