1<sup>st</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

2<sup>nd</sup> RACE Voided claim - insufficient funds  
Dead Heat for PLACE

The claim of #1 "Golden View" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE Voided 2 claims - insufficient funds

4<sup>th</sup> RACE Voided claim - owner not licensed  
Voided claim - submitted without envelope  
Voided claim - submitted for scratched horse  
An objection was lodged by the owner (David

Meah) of second place #8 "Ramadhaan (IRE)" (Reylu Gutierrez) alleging interference by the rider of the unofficial winner #4 "I'mherefortheparty" (Luis Saez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

5<sup>th</sup> RACE #5 "Take Charge Briana" (Luis Saez) fell, unseated her rider near the 3/16 pole, and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized.


6<sup>th</sup> RACE Voided claim - signer not Authorized Agent

8<sup>th</sup> RACE #8 "Thanks Mr. Eidson" (Ricardo Santana, Jr.) finished sixth and BLED

#2 "Chasing Artie" (Luis Saez) trailed the field and was eased. While returning to the unsaddling area the horse began to stagger and he collapsed. Upon the quick arrival of the KHRC veterinarians, the horse was agonal and unresponsive. After attempts to stimulate the horse failed, the horse was humanely euthanized.
