(Tyler Gaffalione) and fifth place #3 "Valerie Blue" (Martin Chuan), the
stewards determined that #3 attempted to go into a tight spot between
horses causing #6 to check sharply and clip the heels of a rival. For the
interference #3 was disqualified from fifth and placed last. Both Moncada
and Giles were transported to the hospital with minor injuries. Neither
horse was injured.
