RACE Race 4 was taken off the turf and contested at one mile on the main track. The change was posted and announced prior to the opening of wagering.

6th RACE #6 "Swanson Lake" (James Graham) finished fourth and was pulled up abruptly while galloping out after the race. The filly required the assistance of the KHRC veterinarians and the horse ambulance. After diagnostics were performed it was determined that the horse had suffered a catastrophic injury to her left hind leg and she was humanely euthanized.

RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#5 "Street Swagg" was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian. The late scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds. Three claims that had been submitted for the horse were voided.
