1st RACE CLEAR

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#1 "Precursory" (Colby Hernandez) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to four and necessitated the cancellation of the Trifecta. The mutuels department made the proper refunds.

3rd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

The claims of both #3 "Ignitis" and #6 "Insolito" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

4th RACE Voided 3 claims - submitted by the same stable for a single horse

Voided claim - track misspelled

#6 "With Purpose" (Tyler Gaffalione) was a late scratch from the post parade on the advice of the KHRC veterinarian. five claims that had been submitted for the horse were voided.

5th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided claim - insufficient funds and signer not Authorized Agent


The claims of both #4 "Infiltrator" and #8 "Town Branch" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.
