- RACE #9 "Empirical Mischief" (Adam Beschizza) was injured in the post parade and was a late scratch on the advice of the KHRGC veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds. A claim that had been submitted for the horse was voided.
- RACE #6 "Viable" (Brian J. Hernanez, Jr.) was pulled up abruptly just past the finish and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the filly had suffered an injury to her left foreleg and was transported to a private clinic for evaluation.
- RACE It appeared that #8 "Canavero" (Gabriel Saez) was eased up just prior to the finish, and was caught at the wire for fourth place by a rival. A Stewards Hearing was scheduled to investigate the matter.
