2nd RACE A Stewards Inquiry was posted involving the top two finishers and, in addition, objections were lodged by the trainer (Steven M. Asmussen) and rider of #1 "Washton" (Kelth J. Asmussen) alleging interference by the rider of #4 "Storm Diva" (Tyler Gaffalione) and also an objection lodged by the rider of #4 alleging interference by the rider of #1 in the stretch. When the close finish was finally posted, #1 was the unofficial winner and the objections by the trainer and rider of the winner were not considered. After reviewing the race replay and interviewing the riders, the stewards found no evidence of interference by the rider of #1. There was no change in the order of finish and the race was posted official

3rd RACE Voided 2 claims - submitted by same stable for a single horse

4th RACE Voided claim - horse name misspelled

5th RACE CLEAR

6th RACE Odd vs. Even wagering was not offered when only one horse with an even number remained in after scratches, in conflict with the rules governing the wager.

#11 "Coco Cool" (William Antongeorgi, III) was pulled up near the 3/8 pole and required the assistance of the KHRG veterinarians and the horse ambulance. After diagnostics were performed, it was confirmed that the horse had suffered a catastrophic injury to his right hind leg and he was humanely euthanized.

7th RACE CLEAR

8th RACE Superfecta and Odd vs. Even wagering were not offered when the field was reduced to five prior to the opening of wagering.

9th RACE Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager.

Jackpot 8 wagering was not offered when the field was reduced to seven prior to the opening of wagering.
