7th RACE CLEAR


8th RACE A Stewards Inquiry was posted involving an incident in the stretch and, in addition, an objection was lodged by the rider of tenth place (last) #9 "Asternia" (Cristian A. Torres) alleging interference by the rider of the unofficial winner, #7 "Bling" (John Velazquez) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #7 angled in while not clear, causing #9 to clip heels and stumble, almost unseating Torres and causing #9 to lose all chance. For the interference, #7 was disqualified and placed tenth (last), behind #9.

9th RACE Voided claim - Insufficient funds

The claim of #4 "First Strike" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
