2nd RACE #12 "Flame of Alberta" (Rodney Prescott) finished last and was treated for a post-race heatstroke by the KHRC veterinarians

4th RACE #11 "Factor Around" (Joseph Talamo) who finished fourth and was chosen as the special, was treated for a post-race heatstroke. A blood sample was collected and she was excused from the test barn

5th RACE Both #4 "Twisted Emotions" (Carlos Diaz) and #5 "Lemon Drop Twist (Mitchell Murrill) finished off the board and were treated for heatstroke by the KHRC veterinarians.

After reviewing the race replay and interviewing the riders, the stewards determined that rider of #7 checked when he lacked room to go between the #4 and #6. There was no change in the order of finish and the race was posted official.
