1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #8 "Martindale" (Ben Curtis) was a late scratch from the post parade on the advice of the KHRGC veterinarian. Six claims that had been submitted for the horse were voided.

#7 "Tonalite" (Luis Saez) was pulled up abruptly near the 1/2 mile pole and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the filly had suffered a catastrophic injury to her left foreleg and she was humanely euthanized. Thirteen claims that had been submitted for the horse were voided pursuant to HISA Rule #2262.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE The claim of #9 "Off Ramp" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #2 "Praying" (Cristian A. Torres) broke through the gate prior to the start and unseated her rider, who was not injured. The assistant starter made a heroic save and held onto the horse, who was then examined by the KHRGC veterinarian and remounted. The eventual start was without incident.
