#7 "Tonalite" (Luis Saez) was pulled up abruptly near the 1/2 mile pole and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the filly had suffered a catastrophic injury to her left foreleg and she was humanely euthanized. Thirteen claims that had been submitted for the horse were voided pursuant to HISA Rule #2262.
