1st RACE CLEAR

2nd RACE #4 "Curlin's Gesture" (Luis Saez) was eased, pulled up near the 1/16 pole, and left the track on his own power.

The claim of #5 "Classic Legacy" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE The race was taken off the turf and contested at 5 furlongs on the main track. The change was posted and announced prior to the opening of wagering.

Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager.

4th RACE CLEAR

5th RACE #5 "Nyquistador" (Tyler Gaffalione) was eased through the stretch, pulled up inside the 1/16 pole and left the track on his own power. After cooling out in the test barn, the claim of #5 "Nyquistador" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.


6th RACE The race was taken off the turf and contested at 1-1/16 miles on the main track. The change was posted and announced prior to the opening of wagering.




